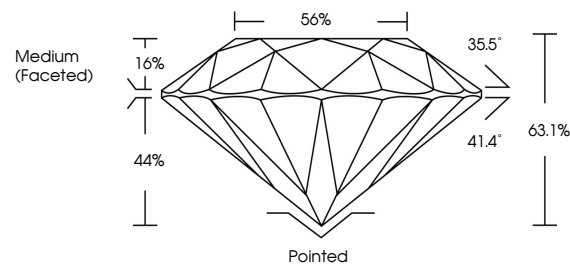

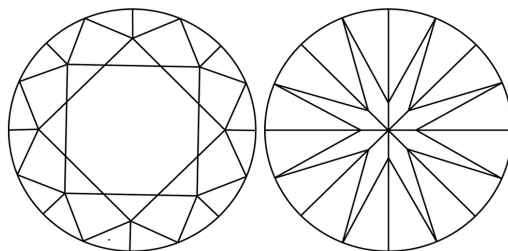

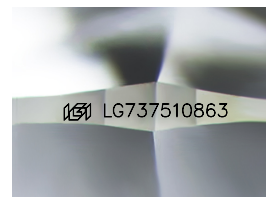


CLARITY CHARACTERISTICS

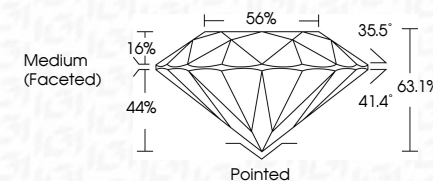

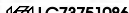
